5. I understand that I must pick up my unsold items **Sunday, February 1<sup>st</sup> between 9am-12pm**. I am responsible for finding my items from the floor using my unsold items report. Any unsold items not picked up by 12:01 pm, will become property of Urban Kids Consignment.
6. I understand Urban Kids Consignment works hard to maintain security at their events but cannot guarantee that there will be no lost, stolen, or damaged items. Urban Kids is not responsible for lost, stolen or damaged items.
7. If an item is over \$50 and does not require to have a large claim tag, I will bring it to the inspecting team's attention.
8. I understand my Seller PreSale ticket, good for 2 adults on Tue Jan 27th, and for Sat the 31st. The ticket will be mailed Monday night. I will share my ticket if I am not using it, so we get more shoppers in the door.
9. I understand that I will have my check mailed to me within 10 business days if not pick up at pickups. There is a \$40 reissue fee. If I am not picking up, I will provide a self-addressed-stamped envelope.
10. My contact information on MSM Consignor home page is correct as this is how Urban Kids will contact me and mail my check if needed.
